YELLOW-JACKET WATER CONSERVANCY DISTRICT PROPOSED BUDGET FOR 2023 SUBMITTED FOR BOARD REVIEW AND APPROVAL

This budget is prepared for consideration by the Board of Directors of the Yellow Jacket Water Conservancy District ("District"). The primary funding source for the District comes from property tax revenues. The assessed value of property within the District is nearly the same for 2023. This budget considers maintaining the District's present mill levy of 0.209 mills. Revenues and expenditures remain consistent.

The District's expenditures over the past several years include an ongoing reservoir feasibility study and research into other viable uses for the District's conditional water rights. The District is pursuing an enlargement to Lake Avery for purposes of storing additional water in the White River Basin. This budget is focused on those efforts. It also includes a matching grant up to \$10,000 for water measurement device display in Meeker.

The District's budget format follows the previous year's format that separates "Operating Expenses," which includes: Postage, Office Supplies, Checks, CPA Fees, Publication Fees, Meetings, Supplies, Treasurer's Fees, Meals, and Miscellaneous reimbursement for unanticipated expenses. "Legal Fees" are limited to such fees and do not include other costs.

The District anticipates incurring additional legal and engineering fees in 2023 as it continues to prosecute its water court applications, develop its long-term master plan for its water rights portfolio, and expand upon previous studies analyzing the feasibility of its water rights. The District also anticipates incurring additional legal and administrative costs associated with the District's primary objective to expand the Big Beaver Reservoir (Lake Avery).

The District's budgetary basis of accounting uses is cash basis.

- 2. That the established tax levy for the Yellow Jacket Water Conservancy District be certified to the respective County Commissioners for Garfield, Moffat, and Rio Blanco Counties.
